"You," "your," the "Company," or "the Company's" mean the corporate recipient of this Request (as applicable, either Glock, Inc., Consult Invest, Inc., or Glock Professional, Inc.) and its officers, directors, employees, advisors, agents, consultants, independent contractors, and former employees; all direct and indirect subsidiaries, divisions, and joint ventures; and the officers, directors, employees, advisors, agents, consultants, independent contractors, and former employees of such subsidiaries, divisions, and joint ventures.
- 3. "Glock Affiliate": Either (i) any of the following legal persons or entities: Glock Privatstiftung, the IGG Privatstiftung, the IGVG Privatstiftung, the Value Privatstiftung, CON Holding GmbH, Glock Horse Performance Center GmbH, Glock Security GmbH, FAIR, Rochus GmbH, Gaston Glock GmbH, GG Hangar GmbH, Glock GmbH, INC Holding GmbH, Glock Gul- und Forstverwaltung GmbH, Glock Health GmbH, Glock Holding GmbH, Glock Ökoenergie GmbH, Glock Technologie GmbH, Glock Services, Glock, Inc., Consultinvest, Inc., Glock Professional, Inc., Glock America SA, Glock America (Uruguay), Glock (H.K.) - 8. For each document the production of which is requested, produce the entire document, along with all attachments, appendices, and exhibits.
- 9. If any document or thing requested was at one time in existence, but is no longer in existence, please provide the following information for each such document or thing:

  - (c) the date upon which it ceased to exist;

- (d) the circumstances under which it ceased to exist;and
- (e) the identity of all persons who have knowledge of the contents

thereof.

  - (a) the date or approximate date of the document;
  - (b) the type of document (e.g., letter, memorandum, manual, etc.);
  - (c) a description of the subject matter of the document;
  - (d) each person who prepared, signed, and/or received the document or any copy thereof;
  - (e) the present custodian(s) of each document;
  - (f) a list of attachments or enclosures to the documents; and
  - (g) the nature of the privilege or protection asserted.
