To my family:

My experiences within the past year prompt me to once again reaffirm my precise instructions and my unconditional wishes for the re-organization of the Glock Group in writing.

In 1999 I decided to restructure the Glock Group and secure it for all succeeding generations to come through the Privatstiftung (trust).

In 2009, I significantly improved the trusts for the benefit of the beneficiaries and adequately provided for the current generation through generous donations and substantial annual contributions, with the ulterior motive to provide start-up capital for possible self-entrepreneurial activities enabling to achieve personal goals and desires. When I started my own business I myself merely had savings from my former executive position at "Kuehler and Metallwarenfabrik" available for disposal. But as the past has shown, through tireless efforts and decades of hard work it was possible to succeed in accomplishing to turn the name Glock and its company into a reputable and world-renowned enterprise.

I deem the structure of this private trust irrevocable as it serves the purpose to generously serve all the family needs and its generations to come.

My volition as founder of the trust has been clearly defined for all future generations to come. I will not deviate from this structure. I have absolute confidence in the executive bodies of the trust that were appointed by me. The trust's board of directors has been given clear instructions and strict guidelines to comply by in order to achieve a tension free climate within the structure, i.e. there will be no harassment, spying, stalking, violation of human dignity or scheming towards me and my environment.

I have been preoccupied with the restructuring for a very long time and had communicated this to you as such on 01/13/2010. I am working on a "Glock code of conduct" which will be implemented and will require all employees and family members who access the benefits to adhere to. I reference the regulations in the trusts deed.

My irrevocable key points are:

No family member on the operational level. I am at the top of the group as chair of the supervisory board, and I wish for Robert and Gaston to be at my side on the supervisory board. I thank my wife Helga for her support and wish her a carefree and good life in her deserved retirement.

Brigitte will leave the company and is sufficiently provided for by me.

I will not allow any interference in my life long business endeavors. Therefore, all employed family members will withdraw from the company's operations. Robert and Gaston have responsibilities on the supervisory board, which I hope will finally establish some sense of peace in the company. I wish for Stefan to have a good education.

With my decision to retire the family from the business, no one's reputation is jeopardized.

I guarantee the agreed upon payments to the beneficiaries for a lifetime. I therefore expect appreciation, compliance and acceptance and the respect I deserve as a father.

My business and I require absolute tranquility and vigor for the furtherance of my phases and projects. Issuance of a copy, authorized only after written consent.
